Chairman May called the meeting to order. Motion by Gullickson, seconded by Peper to approve the agenda. All voted "aye". Motion by Peper, seconded by Firman to approve the minutes of August 24, 2010. All voted "aye".

Schaefers presented pending poor relief cases to the Board. Motion by Gullickson, seconded by Stenberg to approve poor relief case # 20100702 in the amount of \$17,933.77. All voted "aye". Motion by Peper, seconded by Firman to deny poor relief case # 20100807 due to the County only being responsible for the hospital bill if the patient qualifies, and prior approval is required for non-emergency admissions. All voted "aye". Motion by Firman, seconded by Stenberg to approve poor relief case # 20100806 in the amount of \$698.00. All voted "aye".

Auditor Schaefers reviewed 2010 department budgets with the Board.

Motion by Gullickson, seconded by Peper to approve the following resolution, with all members voting "aye":

Motion by Stenberg, seconded by Peper to adjourn to conduct business as Board of Adjustments at 9:10 AM. All voted "aye". Motion by Firman, seconded by Stenberg to resume regular session at 9:20 AM. All voted "aye".

Discussion was held on department physicals.

Marc Blum, Highway Superintendent met with the Board. Discussion was held on the construction of Highway 34. Motion by Peper, seconded by Gullickson to authorize Blum to attend the Regional Local Road Conference October 19-21 in Rapid City. All voted "aye". Motion by Stenberg, seconded by Firman to enter into executive session at 9:45 AM. Reason: personnel-department reviews. All voted "aye". Motion by Firman, seconded by Stenberg to resume regular session at 10:05 AM. All voted "aye".

Terry Albers, Drainage Secretary met with the Board to discuss a letter submitted by Richard Moe regarding drainage.

Tracy Foltz, Director of Operations of MED-Star Ambulance of Brandon, SD met with the Board. Also present were Kristene Rancour-Ambulance Supervisor, Mark Bonrud-Paramedic, Jerry Doyle-Commissioner Elect of Commissioner District #1, and Cherlene Richards and Terry Kjergaard of Keloland TV. Foltz informed the Commission that he was asked by members of the Board to look into providing ambulance coverage for Moody County. Foltz stated he would need more information from Moody County in order to continue to evaluate this option. Commissioner Firman informed Foltz that the County is still in the embryonic stages of deciding what to do with the ambulance service. Commissioner Elect Doyle asked Foltz how many cities Foltz has started a business in, and then left because of not making enough money. Foltz informed the Board that he has pulled his business out of two cities, which were unlike Moody County, as they did not operate a 911-center and they had competing ambulance services. Foltz reviewed his background with MED-Star. The Commission informed Foltz they would provide him with more information on the ambulance service. Foltz, Richards, and Kjergaard left the meeting.

Kristene Rancour, Ambulance Supervisor met with the Board. Also present were Mark Bonrud-Paramedic and Jerry Doyle-Commissioner Elect of Commissioner District #1. Motion by Firman, seconded by Stenberg to offer the full-time Paramedic position to Kimberly Leibel. All voted "aye". Rancour reviewed the July and August monthly reports, and discussed repairs done to the 529-ambulance rig. Commissioner Elect Doyle left the meeting. Rancour presented a travel request. Motion by Firman, seconded by Peper to authorize Rancour to attend the ACLS Re-certification class in Sioux Falls October 7. All voted "aye".

Motion by Gullickson, seconded by Firman to adjourn to conduct business as Joint Board of Commission and Board of Planning and Zoning at 11:25 AM. All voted "aye". Also present was Director of Equalization Brenda Duncan. Discussion was held on building permit fees. Motion by Gullickson, seconded by Peper to resume regular session at 11:40 AM. All voted "aye".

Brenda Duncan, Director of Equalization met with the Board to discuss a request from Sioux Valley Energy to purchase copies of the ortho-photos that the County purchased from Pictometry. Motion by Firman, seconded by Stenberg to sell copies of the 12 mm Pictometry ortho-photos for \$2,000.00. All voted "aye". Discussion was then held on the duties and the pay scale of the Director of Equalization. Motion by Gullickson, seconded by Peper to maintain the current wage scale of the Director of Equalization from Step A (Beginning) to Step H (6 years). After 6 years of employment, the wage of the DOE shall fall under the Senior DOE Category, at \$40,950.30/year, eliminating Step I to Step M of the DOE wage scale. In addition, the wage for the Planning/Zoning Administrator will be \$2,750.00/year. This all will become effective September 13, 2010. All voted "aye".

The Board conducted the public hearing at 1:00 PM for the consideration of the Provisional Budget for 2011. Discussion focused on an upgrade to the CMS System, Property Tax revenue, and Capital Accumulations. Schaefers reviewed the County valuation and the County levy for 2010 payable 2011. Motion by Firman, seconded by Peper to approve the following changes to the provisional budget: increase the Data Processing Budget by \$78,000 to include the CMS System upgrade, increase the Planning/Zoning Budget by \$3,160 due to salary changes, decrease Capital Accumulations by \$40,000 due to no longer needing to accumulate for the CMS Upgrade, increase Cash Applied by \$42,742, and increase Property Tax revenue by \$584 due to the final County value/growth calculation. All voted "aye". Auditor Schaefers will prepare the revised budget for the Board's review on September 28th. The budget hearing concluded at approximately 1:10 PM.

Attorney Paul Lewis met with the Board. Motion by Stenberg, seconded by Firman to enter into executive session at 1:10 PM. Reason: contract negotiations. All voted "aye". Motion by Gullickson, seconded by Peper to resume regular session at 1:20 PM. All voted "aye".

Motion by Peper, seconded by Firman to authorize Chairman May to sign the Stipulation and Agreement for Consent Election regarding the SD DOL Case HF No. 6 E. 2009/10. All voted "aye".

Donna Bittiker, Extension Educator met with the Board. Motion by Firman, seconded by Gullickson to authorize Chairman May to sign the Memorandum of Understanding between The Cooperative Extension Service and Counties of South Dakota. All voted "aye".

Erica Rorvik, County Librarian met with the Board. She thanked the Commission for contributing \$1000 towards the Gates Grant that enabled the purchase of the new computers for the Library. Motion by Gullickson, seconded by Firman to declare the 2 old refurbished computers and monitors at the Library surplus property, and to authorize Rorvik to dispose of them. All voted "aye".

Motion by Gullickson, seconded by Firman to enter into executive session at 2:00 PM. Reason: personnel-department reviews. All voted "aye". Motion by Firman, seconded by Stenberg to resume regular session at 2:10 PM. All voted "aye".

Troy Wellman, Sheriff met with the Board. Motion by Firman, seconded by Peper to declare the Sheriff's 2003 Crown Victoria (VIN 115259) and the Sheriff's 2004 Crown Victoria (VIN 145023) surplus property and to sell them through the process of sealed bids. All voted "aye".

Motion by Stenberg, seconded by Gullickson to enter into executive session at 2:13 PM. Reason: personnel. All voted "aye". Motion by Peper, seconded by Firman to resume regular session at 2:30 PM. All voted "aye".

Motion by Gullickson, seconded by Peper to approve the following resolution, with all members voting "aye":

WHEREAS, Moody County funds the Highway budget through tax dollars and revenue from car licenses, and

WHEREAS, the current cash balance in the Highway fund will not fund estimated expenditures, and

WHEREAS, the Board of Commissioners designated operating transfers out of the General Fund to the Highway Fund for 2010.

NOW, THEREFORE, BE IT RESOLVED that the Operating Transfer out of the General Fund to the Highway Fund in the amount of \$100,000 be approved as outlined in the 2010 Annual Budget.
