UNAPPROVED MINUTES OF February 1, 2011

The Moody County Commissioners met in regular session on Tuesday, February 1, 2011 in the County Commissioners' Room in the Courthouse at 9:00 AM, with the following members present: Tom Peper, Chairman, Jerry Doyle, and Rick Veldkamp, with Lori Schaefers, Auditor as Clerk of the Board. Absent: Commissioners Dan Miles and David Stenberg.

Chairman Peper called the meeting to order. Motion by Doyle, seconded by Veldkamp to approve the agenda as amended. All present voted "aye". Motion by Doyle, seconded by Veldkamp to approve the minutes of January 18, 2011. All present voted "aye".

Discussion was held on the ambulance subsidy agreement between Moody County and the Flandreau Santee Sioux Tribe, and on the subsidy agreement between Moody County and the City of Flandreau. Schaefers informed the Board that she has not yet received a response to the agreement proposal submitted to the Flandreau Santee Sioux Tribe. Chairman Peper and Commissioner Doyle informed the Board they attended the Flandreau City Council meeting, and were informed that the City of Flandreau will not be entering into an agreement to subsidize the Moody County Ambulance Service.

Auditor Schaefers presented surplus property. Motion by Veldkamp, seconded by Doyle to declare the following State's Attorney inventory items surplus property, and to authorize disposal of them as they have no value: Gateway desktop computer, Gateway laptop computer, typewriter, HP Scanjet 3970 scanner, Sony cassette recorder. All present voted "aye". Motion by Doyle, seconded by Veldkamp to declare a table stand, located at the County Library, surplus property and to authorize disposal of it as it has no value. All present voted "aye".

Discussion was held on HB 1071 containing provisions relating to the salaries and per diem of County Commissioners.

Auditor Schaefers reviewed pending poor relief cases with the Board. Motion by Doyle, seconded by Veldkamp to deny case #20110101 due to the patient's notice of emergency hospitalization not being sent to the County within 15 days. All present voted "aye". Motion by Veldkamp, seconded by Doyle to approve case #20110115 in the amount of \$698.00. All present voted "aye".

Auditor Schaefers presented a travel request. Motion by Veldkamp, seconded by Doyle to authorize all interested Commissioners to attend the County Commissioners Workshop in Pierre March 16 and 17, and to authorize Auditor Schaefers to attend the Welfare Workshop in Pierre March 16. All present voted "aye".

Auditor Schaefers reviewed the possibility of the County receiving approximately \$15,000 to be used strictly for reward money to help gather information on crimes committed in rural areas of Moody County. The Commissioners will discuss this issue at the next Commission meeting.

Marc Blum, Highway Superintendent met with the Board. Motion by Doyle, seconded by Veldkamp to authorize Chairman Peper to sign the Striping & Continuing Maintenance contract between Moody County and the State of SD. All present voted "aye".

Motion by Veldkamp, seconded by Doyle to enter into executive session at 9:45 AM. Reason: personnel matters. All present voted "aye". Motion by Veldkamp, seconded by Doyle to resume regular session at 9:55 AM. All present voted "aye".

Marc Blum, Highway Superintendent returned to the meeting. Motion by Doyle, seconded by Veldkamp to approve the quote from Ekerns of Flandreau to install a Lennox TU unit heater in the highway truck shed, at a cost of \$4413.00. All present voted "aye".

Scott Lewis, Courthouse Custodian met with the Board to present a purchase request. Motion by Doyle, seconded by Veldkamp to authorize Lewis to purchase a 2010 35SV-12, 77" x 12' Big Tex trailer in the amount of \$1700.00 from Prairie Wind Trailers of Harrisburg, SD. All present voted "aye". Lewis also informed the Board the window on the south side of the Meeting Center, on the side that is utilized by The Closet, is cracking. The Commissioners will discuss this issue at the next Commission meeting.

Leslie Downer, County resident, met with the Board to discuss his concerns on the Highway 34 project. Downer also expressed his concerns about the lack of snow removal on certain County road intersections.

Motion by Doyle, seconded by Veldkamp to adjourn to conduct business as Joint Board of Commission and Planning & Zoning at 10:40 AM. All voted "aye". Also present was Director of Equalization Brenda Duncan. One plat was reviewed. Motion by Veldkamp, seconded by Doyle to approve the following plat, with all members present voting "aye":
