## UNAPPROVED MINUTES OF October 19, 2010

The Moody County Commissioners met in regular session on Tuesday, October 19, 2010 in the County Commissioners' Room in the Courthouse at 9:00 AM, with the following members present: Martin May, Chairman, Alvin Gullickson, David Stenberg, Tony Firman, and Tom Peper, with Lori Schaefers, Auditor as Clerk of the Board.

Chairman May called the meeting to order. Motion by Gullickson, seconded by Peper to approve the amended agenda. All voted "aye". Motion by Firman, seconded by Stenberg to approve the minutes of October 5, 2010. All voted "aye".

Auditor Schaefers reviewed a poor relief case with the Board. Motion by Peper, seconded by Gullickson to deny case #20101003 due to the individual being indigent by design and able to work but has chosen not to. All voted "aye".

The Board discussed surplus property.

Motion by Gullickson, seconded by Stenberg to adjourn to conduct business as Board of Adjustments at 9:05 AM. All voted "aye".

Motion by Gullickson, seconded by Stenberg to conduct business as Joint Board of Commission and Planning and Zoning at 9:20 AM. All voted "aye". Also present was Director of Equalization Brenda Duncan. One plat was reviewed. Motion by Firman to approve the following plat: Hildebrandt's Conservation Easement, Tract 1, SE ½, 33-107-50. Motion died for a lack of second. The Board will review the plat again at the next meeting. Motion by Stenberg, seconded by Peper for the Moody County Planning and Zoning Board to recommend to the Board of County Commissioners to amend the Zoning Ordinance definition of Structures to include the following sentence: For the purpose of these regulations, utility poles are not considered structures. All voted "aye". Motion by Firman, seconded by Peper to resume regular session at 9:45 AM. All voted "aye".

Brenda Duncan, Director or Equalization met with the Board. Motion by Peper, seconded by Gullickson to authorize Duncan to attend the district meeting in Canistota October 20<sup>th</sup>. All voted "aye".

Gail Meyer, Register of Deeds met with the Board. Also present were DOE Brenda Duncan, Treasurer Linette Christensen, and Brad King of Tyler Technologies. Meyer presented a letter to the Board requesting to purchase FileDirector SBE Software in the amount of \$10,703.96 (including maintenance) and Clerk Track Software/Hardware in the amount of \$20,807.00 (including maintenance), both programs to be utilized by the Register of Deed's Office. The Board took no action at this time.

Brad King of Tyler Technologies met with the Board. Also present were DOE Brenda Duncan, Treasurer Linette Christensen, and ROD Gail Meyer. Discussion was held on the Systems Agreement with Tyler Technologies to update the County software system to the INCODE Financial System and InVision Tax System totaling \$73,485.00 (including maintenance). This program would be utilized by the Auditor, Director of Equalization, Treasurer, and Register of Deeds. Motion by Gullickson, seconded by Stenberg to authorize Chairman May to sign the Systems Agreement between Tyler Technologies and Moody County to update the County software system to the INCODE Financial System and InVision Tax System. All voted "aye".

Motion by Gullickson, seconded by Firman to enter into executive session at 11:00 AM. Reason: personnel/contract negotiations. All voted "aye". Motion by Gullickson, seconded by Firman to resume regular session at 12:00 PM. All voted "aye".

Community Health Nurse Val Luze met with the Board and reviewed the 2010 1 st and 2 nd quarter Public Health Office Reports. Luze briefed the board on services provided to county residents, and informed the Board that Moody County received an immunization award for an over 90% immunization rate for 24-35 month olds being up to date on immunizations. Luze also discussed the Safe Routes to School Program.

Kristene Rancour, Ambulance Supervisor met with the Board. Also present was Ryan Woodward of the Moody County Enterprise. Rancour presented the Board with the Ambulance Department's September report and reviewed the vehicle maintenance logs for the two ambulance rigs.

Tracy Foltz, Director of Operations of MED-Star Ambulance of Brandon, SD met with the Board. Also present were Brian Rueben of MED-Star, Kristene Rancour-Ambulance Supervisor, Jerry Doyle-Commissioner Elect of Commissioner District #1, and Ryan Woodward of the Moody County Enterprise. Foltz submitted to the Board an Ambulance Coverage Proposal stating that the MED-Star Paramedic Ambulance Company is willing to locate and operate a paramedic level ambulance in the city of Flandreau, responding to all 911 calls in Moody County and the territories currently served by the Moody County Ambulance Service. Rancour stressed how often the backup rig is used and that having only one rig housed in Flandreau could sacrifice the quality of

service currently being provided. Doyle informed the Commissioners that if the Board passes a motion to discontinue the County Ambulance Service, he would be forced to take out a referendum petition and take the service to a vote of the people. Kimberly Leibel, ambulance employee joined the meeting. Commissioner Stenberg requested a financial statement, net worth statement, and bond proposal from the owner of MED-Star. The Commissioners will discuss the proposal with the State's Attorney at the next meeting.

Auditor Schaefers presented a list of outstanding warrants for the Board's review. Motion by Peper, seconded by Firman to approve the following resolution with all members voting "aye":

### **RESOLUTION 10101902**

WHEREAS, any unclaimed funds held by Moody County which remain unclaimed by the owner for more than one year after becoming payable is presumed abandoned, and

WHEREAS, a list of outstanding warrants which have not been presented for payment was reviewed by the board of commissioners at the meeting held on Tuesday, October 19, 2010, and

WHEREAS, SDCL 7-22-17 provides for the cancellation of outstanding warrants,

NOW, THEREFORE, BE IT RESOLVED, that a motion was made by Peper and seconded by Firman to declare the claims presented abandoned and authorize the cancellation of said warrants in the amount of \$124.88. This report is being submitted along with payment in the sum of \$124.88 to the Secretary of Revenue.

Auditor Schaefers presented the General Fund Cash Surplus Analysis as of September 30, 2010 as required by the Department of Legislative Audit. Schaefers reported the total unreserved, undesignated fund balance of the General Fund as of September 30, 2010 was \$1,485,857.09. This represents 31.53% of the total appropriations for ¼ of the current year's annual budget plus the subsequent year's annual budget. Motion by Gullickson, seconded by Peper to approve and file the General Fund Cash Surplus Analysis with the Department of Legislative Audit. All voted "aye".

Schaefers discussed the Senior Citizens Budget with the Board. Motion by Firman, seconded by Stenberg to approve the following resolution with all members voting "aye":

WHEREAS, Commissioner Contingency Funds are included in the annual budget, and

WHEREAS, insufficient funds were provided to the Senior Citizens Budget,

NOW, THEREFORE, BE IT RESOLVED, that pursuant to SDCL 7-21-6.1 it was moved and seconded to approve the following Contingency Transfer:

# RESOLUTION 10101901 RESOLUTION DECLARING EMERGENCY/DISASTER

WHEREAS, Moody County, South Dakota has suffered severe damages, due to September rain, which caused excessive flooding.

WHEREAS, the following conditions exist in Moody County as a result of the disaster:

- Washed out road beds on public roads
- Several culverts are washed out
- Several homes sustained water damage

WHEREAS, the following factors contributed to the damages in Moody County:

- Local rain in excess of 5-10 inches
- · Culverts could not handle the amount of runoff causing several roads to wash out
- In addition to local flooding of streams, the rain north of Moody County contributed in causing the Big Sioux to reach over 13 1/2 feet, flooding the Flandreau Park and the Town of Trent.

**WHEREAS**, Moody County has committed all available resources and taken all possible actions within the jurisdiction boundaries to combat and alleviate the disaster, local resources are not adequate to cope with the situation.

NOW THEREFORE, BE IT RESOLVED: That the Board of County Commissioners of Moody County declare an emergency, and

**BE IT FURTHER RESOLVED:** We, the Board of Commissioners of Moody County, respectfully petition the Governor of South Dakota and the President of the United States to provide with all dispatch and remedies proper state and/or federal assistance for the alleviation of this disaster/emergency.
