## RESOLUTION 20111701 A RESOLUTION ENCOURAGING THE WEARING OF MASKS IN MOODY COUNTY

WHEREAS, the Center for Disease Control and Prevention (CDC) has confirmed that COVID-19 is easily spread through the air from person to person who are in close contact with one another; and

WHEREAS, COVID-19 is a severe respiratory disease which, especially among older adults and persons with serious underlying health conditions, can result in serious illness requiring hospitalization, admission to an intensive care unit, and death; and

WHEREAS, the World Health Organization (WHO), the CDC, and the Secretary of the United States Department of Health and Human Services have declared the outbreak of COVID-19 as a public health emergency; and

WHEREAS, according to health data from the South Dakota Department of Health, the number of active cases, hospitalizations, and deaths are increasing across the State of South Dakota, resulting in over 19,000 current cases, over 550 hospitalizations, and over 600 deaths in the State; and

WHEREAS, increased cases and hospitalization place a greater burden on healthcare facilities and healthcare workers, and is taking a toll on individuals, families, and workplaces.

NOW, THEREFORE, BE IT RESOLVED, by the Moody County Commission that:

All persons located within Moody County are encouraged to take the COVID-19 pandemic seriously and comply with public health protocols.

The Moody County Commission endorses the MASKUPSODAK campaign, which is an affiliation of organizations in the State (which includes the South Dakota State Medical Association, South Dakota Association of Healthcare Organizations, South Dakota Chamber of Commerce & Industry, Sanford Health, and Avera Health) that has joined to recommend and promote the wearing of a mask.

The Moody County Commission declares that this is time to act collaboratively on behalf of others, as it is the nature of a pandemic that only collective action that reaches higher rates of compliance will ensure protection to the whole community and reduce this most serious risk to the health of the individual.

BE IT FURTHER RESOLVED, that this Resolution reflects a concern for the health, safety, and welfare of the County and shall become effective upon passage and remain in effect until repealed.
