#### Ag Deprecation on Owner Occupied Homes

WHEREAS, each residence must qualify for ag status under SDCL 10-6-112

WHEREAS, residence much be classified as owner occupied under SDCL 10-13-39.1 thru 10-13-39.3

WHEREAS, the parcel upon which the home resides must be at least 30 acres in size.

WHEREAS, the granting of such designation is discretionary with the Moody County Board of Commissioners; and WHEREAS, The Moody County Board of Commissioners is willing to grant such designation upon the terms and conditions hereinafter set forth.

NOW THEREFORE BE IT RESOLVED, any parcel that meets all the above requirements will receive 35% depreciation on their residence. If there is a change in ownership and/or use the owner(s) will have to qualify.

#### **RESOLUTION 21092101**

Director of Equalization Authorized to Determine Eligibility of Riparian Buffer Strips On Behalf of County Commissioners

WHEREAS, in accordance with South Dakota Codified Law, the Board of County Commissioners may authorize the Moody County Director of Equalization to treat any agricultural land within one hundred twenty feet (120') of a tributary to any lake, river, or stream, as specified in subdivision (1) & (2) of SDCL 10-6-116, as riparian buffer strip for the purposes of taxation; and

WHEREAS, in order for the land to be classified as a riparian buffer strip, it shall meet the requirements of SDCL 10-6-117; and

WHEREAS, for the purposes of designating riparian buffer strips within Moody County, the Board of County Commissioners by and through its Director of Equalization, may determine which waterways constitute a tributary to any lake, river, or stream within its territorial jurisdiction.

NOW THEREFORE BE IT RESOLVED, that the Moody County Board of Commissioners authorizes its Director of Equalization to identify, if the director determines that the agricultural land meets the criteria the land must be assessed pursuant to SDCL 10-6-116 on November first, and shall continue to be classified as a riparian buffer strip for a period of ten years unless there is a change in use or if any of the criteria required under this section are not met. Following each ten-year period, an application to maintain classification as a riparian buffer strip shall be filed with the director before October sixteenth. Classification as a riparian buffer, all tributaries to any lakes, rivers, or streams within the territorial jurisdiction of the county for the purpose of determining riparian buffer strips in accordance with SDCL 10-6-116 & 10-6-117.
