The Board conducted the public hearing for The Moody County Five Year County Highway and Bridge Improvement Plan (Transportation Plan). Matt Amdahl and Mark Lokken, Grovena Township, Melvin Kiecksee, Union Township, David Reker, Blinsmon Township and Gary DeClerk, Alliance Township were present. Open discussion was held with questions, concerns and input on the roads and bridges throughout the county including the bridges to be fixed in the next 5 years.

Andy Muller, Highway Superintendent met with the Board. Motion by Hemmer, seconded by Schiefelbein to authorize Chair Bruning to sign the Amendment to Bridge Replacement Funding Agreement for Bridge 51-195-220. All voted "aye." Muller discussed the Rural Access Infrastructure Program, and a future purchase for a piece of equipment. Motion by Veldkamp, seconded by Hemmer to hire Todd Helfrich, Heavy Equipment Operator at Grade 14-A \$17.59/hr effective September 7, 2022. All voted "aye."

Marty Skroch, Commission Assistant met with the Board. Motion by Hemmer, seconded by Veldkamp to authorize any interested county officials to attend the County Convention held in Pierre, SD on September 12-13, 2022. All voted "aye". Skroch discussed potential changes to SDRS with the Board. Motion by Hemmer, seconded by Veldkamp to support moving full time Ambulance staff to South Dakota Retirement Class B. All voted "aye."

Linette Christensen, Treasurer met with the Board to give an update on county finances.

Troy Wellman, Sheriff presented a purchase request to the Board. Motion by Hemmer, seconded by Miles to approve the warrant printed on August 29, 2022 for \$13,000 to Kasseburg Canine Training. All voted "aye".

Bryan Breitling, Avera Flandreau presented the 2023 Public Health Contract to the Board. Motion by Veldkamp, seconded by Hemmer to authorize Chair Bruning to sign the Public Health Contract for \$41,650. All voted "aye."
