

Work Group Meetings held December 12, 2022, December 20th, 2022 & January 17th, 2023:

Called the PUC regarding Aquifer concerns- Staff analyst stated the PUC does not have their own requirements or regulations surrounding environmental issues such as the aquifer. BUT they work with ERM (Environmental Resources Management). Staff hired the firm to review the application submitted, in this case Navigator. The company reviews any concerns from an environmental perspective and is considered by Staff Analyst when recommendation is brought to the PUC hearing. They will also work with DANR and other state agencies when reviewing application. If there are specific concerns surrounding the environment, comments need to be added to the docket. If represented by an attorney, the attorney needs to submit concerns to the docket. – currently the PUC has hired ERM to review the permit submitted by Summit, and they plan to do the same with Navigator.

Depth must be a minimum of 6' with at least a 2' buffer between any utility or tile lines.

Setback from any residence must be 1,320'. If existing residence is in the setback area, a residence waiver must be signed and recorded in the Moody County Register of Deeds. IF new construction is proposed within the setback area, a waiver of setback from existing pipeline must be recorded in the Moody County Register of Deeds.

Shut off valves must be required on each side of the Big Sioux River when HDD. — Based on the application submitted, the depth for HDD, if used, is 25' to 50'.

Shut off valves must be required at each residence site within 600' of the residence, on both ends- This will only include existing homes.... any new homes that choose to build a home within the setback area will need to sign a waiver.

Provide a reclamation plan when pipeline is decommissioned. - Do we want to require a bond?

We are looking at requiring EMT, Fire Fighters, and Emergency requirements on the CUP vs. making it apart of the ordinance.

PUC will determine if Public or Private use.

Landowners need to be aware and let Navigator know if any land is tied up in CRP or WRP land. – trees included.

All pipelines must bore under, state roads, county roads, township roads, and all driveways.

We need to determine the fee associated with the CUP application.
