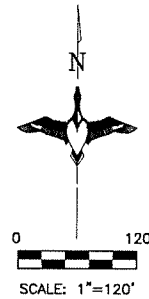
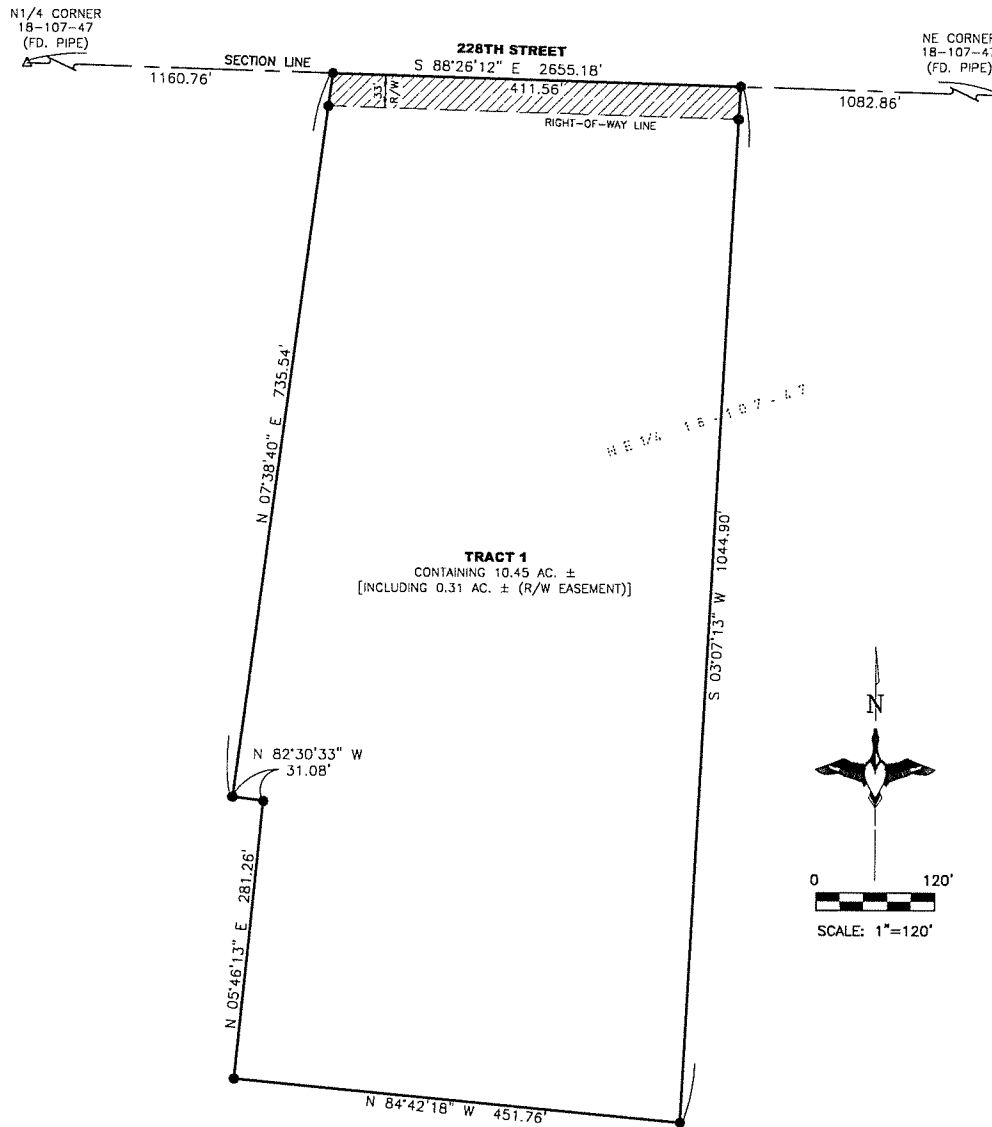

PLAT OF TRACT 1 OF REDDER ADDITION

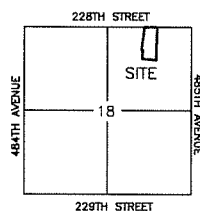
IN THE NORTHEAST QUARTER OF SECTION 18, TOWNSHIP 107 NORTH, RANGE 47 WEST OF THE
5TH PRINCIPAL MERIDIAN, MOODY COUNTY, SOUTH DAKOTA.



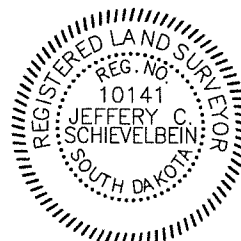
