The Moody County Commissioners met in regular session on Tuesday, December 16, 2025 in the Farmers Room of the Courthouse at 9:00 AM, with the following members present: Chair Carla Bruning, Dave Reker, Jerry Doyle, Dan Miles, and Randy Hemmer, with Tawny Heinemann, Auditor as Clerk of the Board. Chair Bruning called the meeting to order. Motion by Hemmer, seconded by Miles to approve the agenda. All voted "aye". Motion by Reker, seconded by Doyle to approve the following consent agenda with all voting "aye":

Motion by Doyle, seconded by Miles to conduct business as Board of Adjustment at 9:01 AM. All voted "aye". Motion by Doyle, seconded by Hemmer to adjourn and resume regular session at 9:18 AM. All voted "aye."

Marty Skroch, Commission Assistant met with the Board. Motion by Hemmer, seconded by Reker to authorize Chair Bruning to sign Pay Request #2 for the CDBG-Daycare Facility in the amount of \$217,449.41. All voted "aye". Motion by Miles, seconded by Doyle to hire Emmeline Weber, Library Substitute at Grade 5 Step G \$19.14 per hour effective December 16, 2026. All voted "aye". Motion by Doyle, seconded by Miles to approve the renewal of the On-Sale Liquor License for the Flandreau Golf Club. All voted "aye".

Linette Christensen, Treasurer met with the Board regarding two tax deed properties. Motion by Doyle, seconded by Reker to authorize States Attorney Lewis to proceed with the eviction process on parcel 21.16.03.05. All voted "aye". The sale of the two tax deed properties, parcels 21.16.03.05 and 23.01.06.08, will be discussed once both properties are vacant.

Andy Muller, Highway Superintendent met with the Board to an equipment purchase. The Highway and Bridge Budget line has available funds remaining for 2025 and Muller would like to move up the purchase of a 2026 Mack truck that was included in the 2026 Budget. Motion by Doyle, seconded by Miles to approve the purchase request for a 2026 Mack truck in the amount of \$158,500. All voted "aye".

Troy Wellman, Sheriff met with the Board. Also present Tom Klein, Sergeant and Sam Ackermann, Deputy Sheriff. Motion by Miles, seconded by Reker to approve Intoximeters, Inc. invoice in the amount of \$3,143.00. All voted "aye". The cost to the County will be \$909.00 after partial reimbursement from the Highway Safety Federal Overtime Grant. Motion by Miles, seconded by Hemmer to authorize Chair Bruning to sign the 2026 Minnehaha County Juvenile Detention Center contract at a rate of 522.02 per day. All voted "aye". Motion by Doyle, seconded by Reker to authorize Chair Bruning to sign the 2026 Roberts County Jail Housing at \$120.00 per day. All voted "aye".

Chair Bruning notified the Board that she will be resigning at the end of the year. Motion by Miles, seconded by Doyle to accept the resignation of Carla Bruning, Commission Chair effective December 31, 2025. All voted "aye".

A discussion was held on considering paying a health insurance stipend to county employees that do not enroll in the county's health insurance, provided they show proof of other health insurance. This will be discussed further at a future meeting.
